

BARKING AT THE MOON PARADE AND FESTIVAL – VENDOR APPLICATION Oct. 27 at the Fultondale Bark Park

Join us for the Second Annual Barking at the Moon Parade and Festival- hosted by the Friends of the Fultondale Bark Park and the Fultondale Arts Council in Fultondale, Ala. The event is **Sunday, October 27, 2013 from 12-5 pm at the Fultondale Bark Park/Children's Park**. Proceeds from the festival will benefit the Friends of the Fultondale Bark Park.

Vendor spaces will be assigned by number; Sponsor booths will be assigned before vendor spaces. Food vendors will have a special designated area.

VENDOR REGISTRATION:

1. Please register by October 22. Fill out application and pay fee(s) or you may register online at Eventbrite.com – Make checks payable to: FRIENDS OF THE FULTONDALE BARK PARK. No refunds will be given.
2. Interested Food Vendors will fill out form, but will be notified by the Friends of the Fultondale Bark Park Committee if asked to participate.
3. Food vendors must have appropriate business and/or Health Department licenses on-hand at the event.
4. Food vendors selling beverages must serve Coca-Cola products.
5. The following vendor packages are offered based on your designation as for profit or nonprofit. In addition, you must provide your own 10x10 tent, tables and chairs.
6. The Fultondale Bark Park is located off of Stouts Road in Fultondale and directly behind the Children's Park.

Vendor Type	Total Cost
10x10 nonprofit	\$15
10x10 Vendor	\$25
Electricity	\$25 extra

If you need a larger space, you must buy 2 10x10s.

7. Vendors are responsible for staffing, set-up and break down of their booths and must bring own change funds. Vendors must staff their own booths at all times.
8. Vendors must provide tent, tables and chairs.
9. Nonprofit or educational vendors must provide proof of your 501 C (3) designation.
10. Friends of the Fultondale Bark Park will assign space.
11. Friends of the Fultondale Bark Park reserve the right to sell official Barking at the Moon merchandise.
12. Neither the names Barking at the Moon Parade and Festival nor the Fultondale Bark Park can be used with out authorization.
13. Event is rain or shine. All fees are nonrefundable.
14. Vendors are responsible for paying all taxes –Jefferson County and State of Alabama (sales, use and other applicable taxes).
15. Friends of the Fultondale Bark Park, Fultondale Arts Council, City of Fultondale or the Children's Park are not responsible for any lost or stolen property or damaged property during the Barking at the Moon Parade and Festival.

VENDOR SET-UP & BREAKDOWN:

1. All booths must be set up between 8:30 am -11 am on October 27. Breakdown will be immediately at the end of the event. No early breakdown is allowed; Vendors must commit to the entire time of the event.
2. You may drive in to unload and load. Vehicles must be moved before the event begins.
