



ASSUMPTION OF RISK AGREEMENT, RELEASE OF LIABILITY AND COVENANT NOT TO SUE

**IMPORTANT!!!
PLEASE READ CAREFULLY BEFORE SIGNING**

The Great American Backyard Campout (GABC) is an event designed to encourage families to spend time together outdoors. GABC is sponsored by National Wildlife Federation (NWF) in partnership with West Atlanta Watershed Alliance (WAWA), both of which are 501(c)(3) organizations.

I understand and agree that GABC takes place outdoors at the Outdoor Activity Center (OAC). WAWA site is a public park, and I understand it will be open to the public during the GABC event. I understand the OAC site has a pond, fire circle, charcoal grills, a forest, trails, and features that can present hazards to children and other persons in need of supervision. I understand and agree that neither NWF nor WAWA provide supervision of me, my children, or other persons in need of supervision to preserve their safety and well being in connection with this event, even when I am or my children are participating in an activity that is led by a NWF or WAWA member, volunteer or staff. Neither NWF, nor WAWA staff members, or volunteers are responsible for providing such supervision.

I agree to ensure that my child(ren) will abide by all rules and regulations imposed by the organizers of the event. I agree that as parent or guardian, I am responsible for my child's safety and behavior, and that I must help my child respect the rules in order to provide a positive experience for all participants. I also agree that I am solely responsible for any damages my child may cause during the entire event.

I agree, as a consideration of, and in consideration for, being permitted to participate in GABC, to freely and expressly assume and accept any and all risks of injury and death, or property loss or damage, including injury, death, loss or damage attributable to the negligence of GABC, NWF, and LSNC, and its sponsors, promoters or affiliated organizations, and their respective agents, directors, officers, volunteers and employees (the "Released Parties").

I agree to release and forever discharge the Released Parties from any and all responsibility or liability for injuries or damages that result, either directly or otherwise, from my participation in the GABC, or the participation of the minor on whose behalf I am signing this Release. I agree not to make a claim against or sue the Released Parties for injuries or damages relating to any activity related GABC. I further agree to indemnify and hold harmless the Released Parties for all expenses incurred due to my

participation in GABC (or the participation of the minor on whose behalf I am signing this Release), including medical and legal or other expenses, and hold harmless all other participants, even if it is the negligent acts of others that caused the injury or death.

If I am injured or become ill, I consent to and authorize the provision of emergency first aid or medical treatment and I agree to be solely responsible for any costs related to such first aid or treatment.

I further agree to allow all photographs, video and/or any digital images reproduced in association with the GABC to be used in any way by NWF and WAWA, and release all claim to rights in and to those images. I permit these images to be used, re-used, published, and republished as photographs or pictures of me or in which I may be included, in whole or in part, or composite or distorted in character or form, without restriction.

I am aware that this is a release of liability and a contract between myself and NWF and WAWA, and I am signing it freely and of my own accord and I recognize and agree that it is binding upon myself, my heirs and assigns, and in the event that I am signing it on behalf of any minors, I have full legal authority to do so, and realize the binding effect of this contract on them and on myself. In this document, the use of personal pronouns such as "I," "me", and "my" shall be deemed to include any minor on whose behalf I am signing it.

I, THE UNDERSIGNED, HAVE CAREFULLY READ THIS ASSUMPTION OF RISK AGREEMENT, RELEASE OF LIABILITY AND COVENANT NOT TO SUE. I FULLY UNDERSTAND AND AGREE TO ITS CONTENTS.
